REORGANIZATIONAL MEETING, JANUARY 5, 2026, 3:00 P.M.

The Reorganization Meeting of the Stroud Township Board of Supervisors was called to order by Chairwoman & Secretary, Jennifer Shukaitis at 3:00 P.M., at the Stroud Township Municipal Center, 1211 North Fifth Street, Stroudsburg, Pa. Also present were Vice Chairman & Ass't Treasurer, Edward C.
